AMENDMENT

DECLARATION OF CONDOMINIUM

OF

SIESTA GULF VIEW

V. MAINTENANCE, ALTERATIONS AND IMPROVEMENTS

- A. By the Association. The responsibility of the Association shall be as follows:
 - (1) All exterior portions of a unit not considered a part of the unit.
 - (2) To maintain, repair and replace all common and limited common elements, provided that such expenses as to a roof deck shall be assessed only to the owner of the unit to which it is appurtenant.
 - (3) To maintain, repair and replace all conduits, ducts, plumbing, wiring and other facilities for the furnishing of utility services contained in the portions of a unit maintained by the Association and all such facilities contained within a unit that services part or parts of the condominium property other than the unit within which contained, and, after April 30, 2024, but commencing no later than April 30, 2026, to replace all drain pipes that are located wholly or partially within the common elements even if such pipes only serve one unit. Notwithstanding anything to the contrary herein, the Association shall not be responsible for any maintenance, repair, or replacement of such drain pipes serving only one unit after April 30, 2026 other than to complete the work started within the preceding two (2) years, and shall not at any time be responsible for the drains and drain pipes contained within sink enclosures, cabinets, or vanities in units.
 - (4) The Association, its agents or employees, shall have the irrevocable right to have access to each unit from time to time at reasonable hours as may be necessary for the maintenance, repair or replacement of any common elements therein, or for making emergency repairs therein necessary to prevent damage to the common elements, or to other units, and for the purpose of carrying out the provisions referred to in sub-paragraphs 1, 2 and 3 hereof.
